PROPOSED CONSTITUTION

ARTICLE I

Name

This organization shall be known as the AMERICAN BEGONIA SOCIETY. The main office of this Society shall be in Long Beach, California.

ARTICLE II

Purpose

This Society shall be conducted on a non-profit basis, and its purpose shall be to stimulate interest in begonias and shade loving plants; to encourage the introduction and development of new types of begonias and related plants; to gather and publish information in regard to the kinds, propagation and culture of begonias and other shade loving plants; and to issue a bulletin which shall be mailed to all members in good standing.

ARTICLE III

Membership

Memberships in this Society shall consist of two classes: Memberships-at-Large and Memberships through affiliation with any recognized Branch Society. Any person interested in the purpose of this Society may make application for membership, accompanied by the regular dues, either to the Membership Secretary direct or to any recognized Branch. Memberships-at-Large shall be approved by the Board of Directors.

ARTICLE IV

Officers

The Officers of this Society shall be President, President-Elect, Past President, Secretary, Treasurer, Membership Secretary, Editor and/or Business Manager, Research Director, Nomenclature Director, Public Relations Director, three (3) Directors-at-Large, and one Representative Director from each recognized Branch Society, and shall be members in good standing.

Commercial growers or dealers shall not be eligible to hold any elective office

in the Society.

The President-Elect, the Treasurer and one (1) Director-at-Large shall be elected at each annual meeting of the Society; the President-Elect shall serve one year as President and one year as Past President and one year as Past President.

dent; the Treasurer shall serve one year and the Director-at-Large shall serve for three years.

A Representative Director shall be

elected annually by each Branch.

All remaining officers shall be appointed annually by the President subject to the approval of the Board by a majority vote.

ARTICLE V

Board of Directors

The Board of Directors shall consist of the Officers of this Society and shall be the administrative and executive body of the Society.

ARTICLE VI

Meetings

There shall be an annual meeting of the Society, to be held in November of each year at a time and place to be designated annually by the Board of Directors. By a two-third vote of the Directors present, this date may be changed.

ARTICLE VII

Branch Societies

Branch Societies may be organized by any group of seven or more members of this Society who wish to affiliate themselves to forward the work of this Society; and upon approval of the Board of Directors shall be issued a Charter. Upon approval of the majority of the Board of Directors, the Charter of any Branch may be suspended and, after due hearing before said Board, upon action of a majority of the Board may be withdrawn.

ARTICLE VIII

Dues

The dues of this Society shall be one dollar and fifty cents (\$1.50) annually payable in advance. Members in arrears thirty days may be dropped from the membership and their copy of the official publication discontinued. Membership covers the immediate family, except that only one member may receive the official publication and exercise the right of vote, unless additional dues are paid. Memberships shall run one year from the date paid.

ARTICLE IX

Amendments

This constitution may be amended by

a two-thirds vote of the members present at any annual meeting or special meeting called for that purpose, provided that each member of the Society shall have been informed in writing or through the official publication, of the proposed amendment at least ten days previous to the annual meeting or special meeting.

PROPOSED BY-LAWS

ARTICLE I

Duties of Officers

The President shall preside at all meetings of the Society or the Board of Directors, and shall perform such other duties usually pertaining to his office.

The President-Elect shall serve in the absence of the President.

Directors-at-Large shall serve as Vice-Presidents in the order of their seniority.

The Secretary shall keep a record of all transactions of the Society and of the Board of Directors; shall conduct all necessary correspondence; and shall have charge of the records of the Society.

The Treasurer shall have charge of the funds of the Society; shall keep an accurate record of all receipts and disbursements; shall pay out monies only on the order of the Board of Directors; shall prepare an annual budget; and shall file bond in such surety company and in such sum as the Board of Directors may determine.

The Membership Secretary shall receive all dues which shall be deposited immediately with the Treasurer; keep an accurate roster of the membership of the Society; and inform the Business Manager of all changes in membership and have charge of the mailing list of the official publication; of the mailing and selling of back numbers of the official publication, and of the sale and distribution of all other special bulletins and directories.

The Editor shall have charge of the Publications Department; shall edit the official publication and all other publications of the Society and shall cooperate with the Directors of other departments. The Business Manager shall act as the business agent for the Board of Directors and for the Publications Department; shall act as advertising manager for the official publication; shall

act as Purchasing Agent for the Society; and shall file bond in such surety company and in such sum as the Board of Directors may determine.

The Research Director shall have charge of the Research Department; of the importation and development of new kinds of begonias and allied plants; of the administration of the Special Seed Fund; of collecting information relative to the culture, propagation, and housing of begonias and allied plants; of assembling a library for the use of officers and members of the Society; and shall preserve three copies of each issue of the official publication and all other publications of the Society.

Nomenclature Director shall have charge of determining and establishing correct names and species and established varieties of begonias; of approving and registering all newly developed horticultural varieties of begonias; and shall cooperate with the Editor in the publication of the results of his work.

The Public Relations Director shall have charge of the Public Relations Department; of publicising all activities of the Society; contacting prospective members; promoting and assisting in the formation of new Branch Societies.

ARTICLE II

Board of Directors

The Board of Directors shall meet at least four times a year and/or monthly on call of the President or in his absence, by the President Elect, the time and place to be published in the official The Board of Directors publication. shall be the administrative and executive body of this Society; shall transact all business of the Society between annual meetings; pass on applications for membership; arrange for the annual meeting, any special meetings, and any special elections; establish and appoint such special committees as may be necessary to transact the work of this Society or any of its departments; approve the establishment of Branch Societies and issue Charters to them; adopt an annual budget; elect honorary directors; and make such regulations as may be necessary for the good of this Society.

ARTICLE III

Departments and Committees

The activities of the Society shall be

divided into departments and committees under the charge of officers, elected or appointed for such department or committee.

The Department Directors may recommend the appointment of such special officers, assistants, or specialists as may be necessary to properly conduct their department.

Each Department Director shall make a report at the annual meeting and such other reports as may be required by the Board of Directors.

The funds of each department, and of the Special Seed Fund, shall be kept separately by the Treasurer, and each department shall operate under the general budget adopted by the Board of Directors.

ARTICLE IV

Elections

The President shall appoint, not later than July of each year, a Nominating Committee of three, who shall be Presidents of Branch Societies. This Committee shall report at the September meeting of the Board of Directors, at least two nominations for each office to be filled at the annual meeting. Additional nominations may be made by a petition signed by at least fourteen active members, if made and delivered to the Secretary on or before the first day of September. An official ballot shall be sent out with the October issue of the official bulletin and shall contain the names of all nominees.

Members of Branch Societies shall cast their ballots at the first meeting of the Branch Society succeeding the mailing of the ballots, the result of such balloting shall be mailed immediately to the Secretary of the Society.

Eligible voters not affiliated with any branch may mail their ballots to the Secretary of the Society at least ten days prior to the annual meeting. It shall be the duty of the Secretary to keep a detailed record of the ballots and make due report in writing at the annual meeting.

The fiscal year shall start on November the first.

The newly elected officers, together with those still in office, shall meet at the annual meeting, or as soon after as practicable, to select the appointive officers.

Vacancies among the officers, elective

or appointive, shall be filled by appointment by the President.

ARTICLE V

Quorum

Twenty-five members shall constitute a quorum for the annual meeting or any special meeting.

Seven members of the Board of Directors shall constitute a quorum for any Board meeting.

ARTICLE VI

Branch Societies

Any member of this Society may affiliate with any Branch Society, provided he meets the requirements for membership in that branch; a member of one branch may not become an active member of another branch except, that a member of one branch may withdraw and affiliate with another branch provided that both Branch Societies approve.

Each Branch Society must have a Constitution and By-Laws both of which shall be approved by the Board of Directors; it shall require that all members maintain active membership in the American Begonia Society; it must include among its officers a President, a Secretary, and a Representative Director; it may determine its own officers other than those specified above; it may make additional qualifications for membership; it may determine the manner in which its local activities shall be financed; and it may determine its own activities and meetings, provided that these activities and requirements in no way conflict with the National Constitution and/or By-Laws.

No officer of this Society shall be eligible to hold an elective office in any branch, except that the Representative Director shall be a member of the Board of Directors of this Society, and shall attend meetings of that Board when possible; shall make such reports, recommendations or communications as will further the interest of this Society.

Each Branch Society shall file with the Secretary a copy of its Constitution and By-Laws, and all subsequent amendments.

Each Branch Society shall file with the Membership Secretary, the names and addresses of all new members together with their dues, as received.

Shady Corner Bulbs

by Leila Campbell Mathewson Pasadena, Calif.

• Finding bulbs that bloom happily in the shady nook of the garden, is like coming upon a striking piece of costume jewelry to set off a favorite dress. It is especially gratifying to have unusual flowers for guests to exclaim over. To all good gardeners, tucking into the soil modest brown bulbs, plump with stored food, has a peculiar fascination. There is the anticipation of beauty to come, a period of waiting when one almost forgets what was planted, then the sudden delight of finding your borders and porches jeweled with delicately tinted buds.

Vallota purpurea, the Scarborough Lily, will surprise most of your friends. It is a rather hardy South African, growing well in southern gardens, and a striking pot plant in any climate. The large bulbs send up strong flower stalks, often 3 ft. tall, crowned with terminal umbels of salmon-orange flowers. The florets are funnel-shaped, about 3 inches across, resembling those of the much admired Clivia. Narrow, basal leaves, generally 2 feet long appear at the same time as the flowering stalk, and die down in early fall. These are a good green and, after the blooming season is over, give a nice variation of texture to the shady border or group of pot plants. Like most shade plants, it thrives in moist soil. Vallota is especially good in the filtered shade of trees, mass shrub plantings, and in groups along pools.

Another South African shade lover, even less well known, is the Schizostylis, or Kafir Lily. Like Vallota, it may be grown outdoors in the warmer climates and is a beautiful pot plant anywhere. The name is from the Greek, meaning to cut and style, in allusion to the thread-like segments of the style. Schizostylis belongs to the Iris family. Var. Mrs. Hegerty has clear pink lilyflowers, about 2 inches across, rising to a height of 1 to 2 feet. Narrow, grasslike leaves appear before the flower stalk. This delightful lily should be more in cultivation that it is. The easy propagation is by root stock division in the early spring. After flowering in the fall, the thick, fleshy root stocks should be dried and stored until March. The plants need partial shade and plenty of water during the growing period. to produce their loveliest blooms.

Plantly Speaking — On the Shady Side

• It may be a rank grower, but it can easily be controlled, and for all its faults, Ajuga reptans, Carpet Bugle, is very useful as a carpeter. (If one may use that word, for it grows with its leaf rosettes closely attached to each other.) I have found it very practical here in Southern California even as a ground cover under our Pepper and Eucalyptus trees. Those of you who have had experience, know that these trees rob so much of the soil's good, that growing anything else is a problem.

Ajuga reptans increases in much the same manner as the strawberry. It forms deep green, dense mats that will take a lot of abuse. It has two faults, however, easily corrected by running the lawn mower over the area at the right time. One is that the flower stalks may become quite shabby after flowering; the other is that the old foliage matures and turns somewhat brown in the Fall. Mowing in mid-September and removing the old foliage induces fresh young growth that remains evergreen

here through the Winter.

The deep blue flowers bloom in long succession on the little mint-like spikes of about six to twelve inches high. There are white-flowered and purple-flowered varieties and variegated forms of this Bugle Weed, as it is still sometimes called. Charming as the flowers are, the foliage is the chief asset. The most demanding requirement is the right amount of water, not an exorbitant supply, but the right amount, keeps that lush appearance that makes it so useful and attractive.

BEGONIA ARTHUR MALLET

Question: I have lost three plants of Begonia Arthur Mallet in the last year. It seems that I can't keep them growing. The florist said "keep them warm and out of a draft" but still they drop their leaves, with not a sign of disease or insects I even use rain water which has given me very satisfactory results with the fifty varieties of other Begonias I am growing but this one, yet, with all the bother, I want to keep this last plant I have of Arthur Mallet; the color is so attractive I have had much help from the Begonian for three years, and look for a little help now—please.

Answer: By Annie C. Robinson. B. Arthur Mallet needs a rest after blooming. We grow it out-of-doors in the summer, and take in indoors for the Winter, but we believe all things need a rest once in awhile, so do not worry when the new leaves are smaller and the old ones turn yellow then drop off. We do not try to stimulate it into new growth until it again shows an urge to grow, giving it only enough water to keep it from drying out. When it starts new growth then give it new soil and more water. It will thank you for the rest and the change by being more beautiful than ever.

News Notes From The ABS Library

• Mrs. Annie C. Robinson of the Rosecroft Begonia Gardens has donated an out-of-print and rare pamphlet to the association library. "The Philippine Species of Begonia," by E. D. Merrill, 1911, is a study of fifty-nine varieties of begonias found in the Philippines. Botonical exploration since this pamphlet was published has increased the number of species known to be native to the islands but the student will find an excellent description of the species listed. There are no illustrations with the text.

"How to Grow Tuberous Begonias," by Norvell Gillespie of the Sunset Magazine staff was written especially for the western amateur. It gives tips and information which the more experienced grower might also find useful. Propagation, culture and pests are covered briefly. A good handbook for those who read and run. The San Francisco Fall Flower Show

• Each year the San Francisco Fall Flower Show is held in the Rotunda of the City Hall, Civic Centre, in San Francisco, and is predominantly a Dahlia show.

Last year, the San Francisco Branch of The American Begonia Society, entered this show for the first time and was so well received that it was resolved to double our space for this year.

The Show is over, but the memory lingers on, not only in the hearts of those who participated but in the minds of some thirty thousand who attended the two-day exhibition held September 2nd and 3rd, 1942.

The Begonia exhibit of the S. F. Branch and members was one of the focal points of the show and aroused the comment of not only the public but of the Dahlia Society itself, who sponsored the show. Our exhibit was a table arrangement covering forty square feet of Rex, Fibrous, and potted and cut Tuberous Begonias. This entry took second place in competition with all Garden Clubs.

Grouped about the main exhibit were individual tables of William Moxon, Dr. Mervyn Hirschfeld, Messrs. Wm. Logsdon, Wm. Sharp, Harry F. O'Donnell, Al Stettler, L. Tivoll and Mr. Sheppard with those of Miss M. May, Mr. and Mrs. Mac Donald, Mr. and Mrs. Ira Allyn and Mrs. B. Scagen. There was also a separated table on Begonia culture. Many First and Second prizes were awarded these individual exhibits. The Show Committee consisting of Oliver Kerlein (Chairman) Miss M. May, Ira Allyn and Wm Sharp with assistants worked hard and assiduously to put on one of the best Begonia arrangement exhibits to be seen in any flower show so far.

Yes, the flower show is over, but the memory lingers on. It crystalized, bloomed and faded away, but will bloom again, we hope, next year, for we believe there is a great message in the beauty of flowers.

The City of Oakland The Begonia Center Of the STATE?

- It is hoped that the many enthusiastic members of Palomar Branch, including Vista, Escondido and Fallbrook, will evolve some way of keeping in touch with each other while working for victory. Organizations of this kind are particularly valuable and so much that is beneficial can be accomplished together in the spirit of gardening that is difficult to achieve individually.

• Question: How should I care for Tuberous Begonias after they are finished blooming?

Answer by Frank Reinelt: Either where space is needed before the Begonias have finished their growing season or in cold regions were danger of freezing is prevalent, the plants may be lifted with a large clump of soil, the foliage stripped from the stems and then placed in a cool dry place where they will slowly ripen. When the stems have fallen away and the soil has become thoroughly dry they can be shaken out of the dirt and stored away. In that manner the tubers will not suffer any setback.

New Begonia Duchess of Windsor

• About two years ago there appeared in a pot of seedlings in our greenhouse, one Begonia which grew with amazing rapidity. Needless to say, it was watched, and as it grew larger we wondered at its vigor and size. Finally, it flowered with great, huge clusters of about fifty or more flowers to the cluster, mostly males, of a delightful soft pink, and oh! produced so profusely.

The leaves are large on the older plants, but smaller on the young ones, at times they are quite round but often having a long point and in some so pointed as to resemble the rubras. The color is light lettuce greeen becoming darker and slightly tinged with red in

strong sunlight.

Begonia Duchess of Windsor is fine for baskets if pinched to induce bushiness. The flowers are so abundant that young plants headed back several times look like a Christmas Begonia. The flower clusters hang in a drooping fashion as in the Coccinea (rubra) with a strong resemblance to the same Begonia. B. Duchess of Windsor (semperflorens x Coccinea var. Pink rubra) was named in honor of and by permission of Her Grace the Duchess of Windsor.


